Section 3. Hazards identification

Physical state : Solid. [Granular solid. Prills]
Emergency overview : MAY CAUSE RESPIRATORY TRACT, EYE AND SKIN IRRITATION.

Eyes : Slightly irritating to the eyes.

Section 4. First aid measures

- Eye contact** : Check for and remove any contact lenses. Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical attention immediately.
- Skin contact** : In case of contact, immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse. Clean shoes thoroughly before reuse. Get medical attention immediately.
- Inhalation** : Move exposed person to fresh air. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. Loosen tight clothing such as a collar, tie, belt or waistband. Get medical attention immediately.
- Ingestion** : Wash out mouth with water. Do not induce vomiting unless directed to do so by medical personnel. Never give anything by mouth to an unconscious person. Get medical attention immediately.

Section 5. Fire fighting measures

- Flammability of the product** : May be combustible at high temperature.
- Products of combustion** : These products are carbon oxides (CO, CO₂), nitrogen oxides (NO, NO₂ etc.), ammonia (NH₃).
- Explosion hazards in the presence of various substances** : The product itself is not combustible but it can support combustion, even in absence of air. On heating it melts and further heating can cause decomposition, releasing toxic fumes containing nitrogen oxides and ammonia.

Section 6. Accidental release measures

- Personal precautions** : No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Provide adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Put on appropriate personal protective equipment (see section 8).
- Environmental precautions** : Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air).
- Methods for cleaning up** : Move containers from spill area. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Vacuum or sweep up material and place in a designated, labeled waste container. Dispose of via a licensed waste disposal contractor. Section 7. Handling and storage

- Handling** : Avoid creating dust when handling. Avoid contamination by any source including metal powder and organic materials. Keep away from heat, sparks and flame. Prevent moisture pick-up in handling and storage.
- Storage** : Store and use away from heat, sparks, open flame or any other ignition source. Avoid contact with combustible materials. On farm keep away from hay, grain, diesel, etc.

Section 8. Exposure controls/personal protection

- Engineering controls** : Use only with adequate ventilation. If user operations generate dust, fumes, gas, vapor or mist, use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure to airborne contaminants below any recommended or statutory limits.

- Eyes** : Safety eyewear complying with an approved standard should be used when a risk assessment indicates this is necessary to avoid exposure to liquid splashes, mists, gases or dusts.

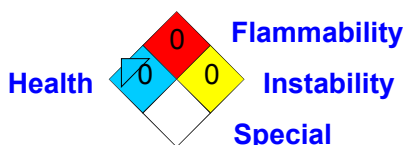
