2. HAZARDS IDENTIFICATION

Main hazards: Injurious to health by ingestion or inhalation of excessive quantities.

Contains: 7% nitrogen (N), 13% phosphate (P₂O₅), 34% potash (K₂O), 12.5% zinc (Zn)
