### 2. HAZARDS IDENTIFICATION

**Main hazards:** Injurious to eyes and skin.

### 3. COMPOSITION / INFORMATION ON INGREDIENTS

**Contains:** 4% w/w = 69g/l (0.58lb/gal) nitrogen (N), 15% w/w = 250g/l (2.1lb/gal) calcium (Ca), 3% w/w = 50g/l (0.42lb/gal) boron (B), 6% w/w = 100g/l (0.83lb/gal) zinc (Zn)

### 4. FIRST AID MEASURES (SYMPTOMS)

**Skin contact:** There may be mild irritation at the site of contact.

**Eye contact:** There may be irritation and redness.

**Ingestion:** There may be irritation of the throat.

**6. ACCIDENTAL RELEASE MEASURES**
