### 2. HAZARDS IDENTIFICATION

**Main hazards:** Injurious to health by ingestion or inhalation of excessive quantities.

**Other hazards:** Contains particles in suspension. Injurious to eyes and skin.

### 3. COMPOSITION / INFORMATION ON INGREDIENTS

**Contains:** 19.5% w/w = 35% w/v (350 g/l) (2.92lb/gal) Zinc (Zn) as zinc oxide, 14.0% w/w = 25% w/v (250 g/l) (2.09lb/gal) Manganese (Mn) as manganese carbonate.

### 4. FIRST AID MEASURES (SYMPTOMS)

**Skin contact:** There may be mild irritation at the site of contact.

**Eye contact:** There may be irritation and redness.

**Ingestion:** There may be soreness and redness of the mouth and throat. There may be difficulty swallowing. Nausea and stomach pain may occur. There may be vomiting.

**Inhalation:** Absorption through the lungs can occur causing symptoms similar to those of ingestion.

### 4. FIRST AID MEASURES (ACTION)

**Skin contact:** Wash immediately with plenty of soap and water.

**Eye contact:** Bathe the eye with running water for 15 minutes. Consult a doctor.

**Ingestion:** Wash out mouth with water. Do not induce vomiting. If conscious, give half a litre of water to drink immediately. Consult a doctor.

**Inhalation:** Remove casualty from exposure ensuring one's own safety whilst doing so. Consult a doctor.

### 5. FIRE-FIGHTING MEASURES

**Extinguishing media:** Suitable extinguishing media for the surrounding fire should be used. Use water spray to cool containers.

**Exposure hazards:** In combustion emits toxic fumes.

**Protection of fire-fighters:** Wear self-contained breathing apparatus. Wear protective clothing to prevent contact with skin and eyes.

**6. ACCIDENTAL RELEASE MEASURES**

**Personal precautions:** Refer to section 8 of SDS for personal protection details. Mark out the contaminated area with signs and prevent access to unauthorised personnel. Turn leaking containers leak-side up to prevent the escape of liquid.

**Environmental precautions:** Do not discharge into drains or rivers. Contain the spillage using bunding.

**Clean-up procedures:** Absorb into dry earth or sand. Transfer to a closable, labelled salvage container for disposal by an appropriate method.

**Handling requirements:** Avoid the formation or spread of mists in the air. Avoid direct contact with the substance.

**Storage conditions:** Store in cool, well ventilated area. Keep container tightly closed.
