Main hazards: No significant hazard.

3. COMPOSITION / INFORMATION ON INGREDIENTS

Contains: 12% nitrogen (N), 13% phosphate (P₂O₅), 9% iron (Fe)

4. FIRST AID MEASURES (SYMPTOMS)
