Nitrogen is essential for structural and functional proteins and stimulating growth. Sulfur is an important component of proteins and required for nitrate metabolism. Together, nitrogen and sulfur create a synergy for providing a quick green-up response. Formulated for superior handling due to particle hardness compared to urea and ammonium sulfate, but can easily be solubilized to be placed into solution for spraying.  
Less dust, therefore, less nutrient loss. Homogeneous formulation allowing for consistent amounts of nitrogen and sulfur on each particle for preventing nutrient segregation.  
Spreads consistent without noticeable striping and irregular growth patterns.

**Recommendations for Use on Turf:**

For best product performance, always apply using best management practices for region and turf species. Apply only when turf is actively growing and with equipment that has been properly calibrated. Apply 0.25 – 1.75 pounds of YaraVera Amidas Turf per 1,000 square feet. Apply irrigation directly after application for best results.  
Dry applications: 0.5 - 0.7 pounds nitrogen per 1,000 square feet.  
Spray applications: 0.10 – 0.7 pounds nitrogen per 1,000 square feet in a minimum spray volume of 30 gallons per acre for low rate (0.10 LBS. N/1000ft<sup>2</sup>) and 80 gallons per acre for high rate (0.7 LBS. N/1000ft<sup>2</sup>).
