This product is a homogeneous formulation and allows for consistent amounts of nitrogen and potassium on each particle for preventing nutrient segregation, thus enhancing the consistency of spreading without noticeable striping and irregular growth patterns. Additionally, YaraRega NK GREEN is well suited for spoon-feeding applications by easily solubilizing the product; this is perfect for providing the right amount of nutrition at the right time.

**Suggestions for Use on Turf:**

For best product performance, always apply using best management practices for region and turf species. Apply only when turf is actively growing and with equipment that has been properly calibrated. Apply 0.5 – 5 pounds of YaraRega NK GREEN per 1,000 square feet. Apply irrigation directly after application for best results.  
Dry applications: 0.5 – 1 pounds nitrogen per 1,000 square feet.  
Spray applications: 0.10 – 0.2 pounds nitrogen per 1,000 square feet in a minimum spray volume of 30 gallons per acre for low rate 0.10 LBS. N/1000ft<sup>2</sup>) and 80 gallons per acre for high rate (0.2 LBS. N/1000ft<sup>2</sup>). It is important to note, that all products that are solubilized, should be screened before placing into spray tank.
